

**BOARD OF EDUCATION  
RIDGEDALE LOCAL SCHOOL DISTRICT  
MARION, CRAWFORD, AND WYANDOT COUNTIES, OHIO**

The Board of Education (the "Board") of the Ridgedale Local School District, Marion, Crawford, and Wyandot Counties, Ohio (the "School District"), met in regular session on July 19, 2021, at 6:30 p.m., in the offices of the Board, 3013 Hillman Ford Road, Morral, Ohio 43337, with the following members present:

Mr. Roush introduced the following resolution and moved its passage:

**RESOLUTION DECLARING INTENT TO PROCEED  
WITH ELECTION OF THE QUESTION OF  
RENEWAL OF AN EMERGENCY TAX LEVY  
(R.C. Section 5705.194 – 5705.197)**

WHEREAS, on June 28, 2021, the Board passed a resolution declaring the necessity, in order to provide for the emergency requirements of the School District, to levy a renewal emergency tax levy, which is a tax in excess of the ten-mill limitation, to raise the amount of \$575,034, which is a renewal of all of an existing emergency tax levy, which was approved by the voters of the School District on November 8, 2016, for each year that said levy is in effect; and

WHEREAS, the Marion County Auditor has certified to the Board that an estimated annual levy of \$575034.00 (3.72) mills for each one dollar of valuation, which is thirty seven and two tenths cents (\$0.372) for each one hundred dollars of valuation, will be required to produce the annual amount set forth in the resolution of June 28, 2021;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Ridgedale Local School District, Marion, Crawford, and Wyandot Counties, Ohio, a majority of the members thereof concurring, that:

Section 1. The Board desires to proceed with the submission of the question to the electors of the School District.

Section 2. The Treasurer of the Board is hereby directed and shall certify, not later than August 4, 2021 (which date is not less than 90 days prior to the Election Date, as defined below), to the Marion County Board of Elections a copy of the resolution of June 28, 2021 and a copy of this resolution together with the amount of the average tax levy expressed in dollars and cents for each one hundred dollars of valuation, as well as in mills for each one dollar of valuation, as estimated by the Marion County Auditor.

Section 3. The Treasurer of the Board is hereby directed and shall simultaneously certify to the Marion County Board of Elections that the number of years the levy is to run will be five (5), and that the levy will include a levy on the 2022 tax list (2023 collection year) if approved by a majority of the electors voting thereon.

Section 4. The question of levying the renewal emergency tax levy shall be submitted to all the electors in the entire territory of the School District at the election currently scheduled for November 2, 2021 (the "Election Date"). All the territory of the School District is in Marion, Crawford, and Wyandot Counties, Ohio.

Section 5. The form of the ballot to be used at said election shall be substantially as follows:

Shall a levy renewing an existing levy be imposed by the Ridgedale Local School District, Marion, Crawford, and Wyandot Counties, Ohio for the purpose of providing for the emergency requirements of the Ridgedale Local School District, in the sum of \$575,034, and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average thirty seven and two tenths cents (3.72) mills for each one dollar of valuation, which amounts to thirty seven and two tenths cents (\$0.372) for each one hundred dollars of valuation, for a period of five (5) years?

It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
